### Refund Policy

Cancellations due to reasons other than visa rejection:

1. If the F-1 student visa is rejected by the USCIS, a student is entitled to a 100% refund of the \$250 deposit fee but shall be responsible for the application fee. If a student wants to hold their spot for the future, no fees are refundable. In this instance, the student is encouraged to re-apply for a visa and enroll in the same level program within three months.
2. If the student cancels their enrollment after receiving Admission letter, but before confirming their enrollment, a student is entitled to a 100% refund of the \$250 deposit
3. but shall be responsible for the application fee. A student may hold their spot for three months with payment of the \$250 deposit.



4. If the student cancels enrollment after confirmation and after paying the deposit to the school, but before orientation, the application fee, express mailing fee and deposit are not refundable.
5. If the student cancels enrollment after the start of the program, the application fee, express mailing fee and deposit are not refundable. In addition, payment for classes held will be deducted from the remainder of the tuition.
6. We do not accept responsibility for costs incurred due to flight delays or cancellations.
6. Refunds or partial refunds will not be given for public holidays, for days missed during the program or for late arrival or early departure.'
7. Material fees (books and supplements) are NON-REFUNDABLE.
8. If High Expectations cancels a student's enrollment due to unsatisfactory attendance or unacceptable behavior, according to the USCIS requirements for international students, no refunds shall be made.
9. Student shall be responsible for bank fees incurred for overseas payments.

### Refund Procedure

1. A request to cancel an enrollment, or a request for a refund, MUST be made, in writing, to the Chief Financial Officer. Any refund will be paid directly to the person who originally paid the program fees.
2. Inquiries regarding refund calculations must be made, in writing, to the Chief Financial Officer. If a refund is approved, the funds will be transferred to the original account within 14 days of approval. Refund method will be the same as the original payment method.
3. Students may submit a formal grievance within 30 days of receipt of notice of denial of their refund. Grievances must be submitted, in writing, to the school Director. After consideration of all available evidence, the Director may: (1) issue a refund of the appropriate amount, or (2) dismiss the grievance.
